

## ISO 45001:2018 Implementation Training Course Details

### Overview

Using a well-structured Case Study, real application examples and practical exercises, this course helps participants develop a hands-on understanding that will facilitate the implementation of a world-class Occupational Health and Safety Management System.

  - How to determine the risks and opportunities within the context of the organization, within the hazards identified, as well as within the organization's processes.
  - How to determine the legal requirements.
- The certification process.

### Prerequisites

The ISO 45001:2018 Amendment 1 Implementation training course does not have any prerequisite courses.

For individuals with little or no previous knowledge of ISO 45001 or Health and Safety Management Systems, who would like to maximize their knowledge; we recommend Mireaux's Fundamentals or Advanced Document Control courses as a preamble and introduction to management systems.
